The HLB's TALON II is the best solution for the release and retrieval system of lifeboats currently in service that must comply with new regulation MSC.1/Circ.1392 no later than the first scheduled dry-docking after 1st July 2014, but not later than 1st July 2019.

These existing on-load hooks should be replaced with safer hook systems according to New regulation. The re-hooking to HLB's TALON II will be the greatest choice since it improves crew safety and increases their confidence in lifeboats.

Round Cam

The Round cam shall be designed so that, when it is fully in the closed position, the weight of the lifeboats does not cause any force to be transmitted to the operation mechanism.

Safety Pin

Safety Pin locks the hook against accidental release and ensures the correct hook reset when inserted.

Corrosion resistant materials such as Duplex Stainless Steels are used and it means to no need coating or galvanizing to long-term operation.

Easy to operate and maintain


Clearly visible and easily understood indications make the operation and maintenance with the hooks safe and fast.
